- Q. Did your alleged father ever have any brothers or sisters?
- A. He has 5 brothers and 1 sister.
- Q. What are their names, ages, and present whereabouts?
- A. YEE THING; he would be 32 years old, if living; my mother told me that he died in the U.S. a long time ago - I never saw him.
YEE WING; 17 years old; single; he is in LEN MEE Village, SND, China.
YEE QUONG; 16 years old, single; he is in LEN MEE Village, SND, China.
YEE FAI; 15 years old; single; he is in LEN MEE Village, SND, China.
YEE YOU; 14 years old; single; he is in LEN MEE Village, SND, China.
My father's sister's name is YEE MAY; 35 years old; my mother said that she was single; she did not say where she was living at the present time.
All my father's brothers and sister were born in LEN MEE Village, SND, China.
- Q. Have you ever seen any of your alleged father's brothers and sister?
- A. My mother told me that I saw YEE WING, YEE QUONG, and my father's sister, YEE MAY, when I was a baby, before we moved from LEN MEE Village, SND, China. I have never seen any of them since. I don't ever remember seeing them.
- Q. Do you know when your alleged paternal uncle, YEE THING, first came to the U.S.?
- A. I do not know.
- Q. Do you know if he has any family?
- A. No, I never heard.
- Q. Did any of your alleged father's other brothers, besides YEE THING, ever come to the U.S.?
- A. No, I never heard.
- Q. Were any of your alleged father's brothers ever married?
- A. I do not know - I never heard.
- Q. Are your paternal grandparents living?
- A. Yes, they are both living.
- Q. What are their names, ages, and present whereabouts?
- A. My paternal grandfather's given name is YEE GUEY; his marriage name is YEE MON LAI; he is 58 years old; he is somewhere in the U.S. I never saw him.
My paternal grandmother's name is DARE SHEE; she is 56 years old, and living in LEN MEE Village, SND, China. I last saw her in my house in HIN VILLAGE, HPD, China, about 4 days before I left to come to the U.S.
- Q. How did she happen to be in your house at that time?
- A. She came to see me because my mother told her that I was coming to the U.S.
- Q. How did your mother get word to your paternal grandmother that you were coming to the U.S.?
- A. She did not tell me - I do not know.
- Q. How long did your paternal grandmother remain in your house at that time?
- A. She stayed in our house two days, and then she returned to LEN MEE Village, SND.
- Q. Had you ever seen your paternal grandmother prior to her visit to your house at that time?
- A. My mother told me that I saw her when I was a little boy in LEN MEE Village, but I don't remember seeing her.
